All abstracts and papers will be subjected to a "blind review" by at least two members of the Scientific Committee. Based on Scientific Committee evaluation, an abstract or paper can be rejected or accepted by the Conference Chairs.

By providing the chance to submit research papers for publication, the conference hopes to promote the exposure of the research presented at the site on a global scale.
